ORDER:-

- 1. In the G,.O.1st read above, the Government have introduced "Andhra Pradesh Sustainable Electric Mobility Policy, 4.0 (2024-29)" with vision "to establish Andhra Pradesh as a premier global hub for high-value EV manufacturing in India, through strategic demand and supply initiatives, to nudge towards e-mobility adoption and to promote sustainable end-of-life use practices, with the goal of achieving carbon neutrality (Scope 1 emission) from transport sector by 2047".
- 2. In the "Andhra Pradesh Sustainable Electric Mobility Policy, 4.0 (2024-29)", the Government provided incentive by way of 100% exemption from payment of motor vehicles tax in respect of all Electric Vehicles registered in the State for 5 years except the Hybrid e-4 wheelers.
- 3. In pursuant to the "Andhra Pradesh Sustainable Electric Mobility Policy, 4.0 (2024-29)" in the G.O. 1st read above and in the circumstances reported by the Transport Commissioner, AP in the references 3rd and 5th read above, after careful examination of the matter, Government hereby decided to exempt 100% tax on all Electric Vehicles purchased and registered in the State for 5 years except the Hybrid e-4 wheelers, from the date of issue of notification till such period which is Coterminous with Andhra Pradesh Sustainable Electric Mobility Policy, 4.0 (2024-29)" issued in the 1st read above.
- 4. The following Notification shall be published in the Extra-Ordinary issue of Andhra Pradesh Gazette dated:10.01.2025

NOTIFICATION

In exercise of the powers conferred by Clause (a) (ii) of Sub- Section (1) of Section 9 of Andhra Pradesh Motor Vehicles Taxation Act, 1963 (Act 5 of 1963), the Governor of Andhra Pradesh hereby grants exemption from payment of 100% tax payable under the said Act from 10.01.2025 to till such period which is Coterminous with Andhra Pradesh Sustainable Electric Mobility Policy, 4.0 (2024-29)" issued in the G.O.Ms.No.88 (Industries & Commerce (P&I) Department), Dated:11-12-2024 in respect of all Electric Vehicles / Battery operated vehicles defined under Rule 2 (u) of Central Motor Vehicles Rules, 1989, purchased and registered in the State for 5 years except the Hybrid e-4 wheelers.

Explanation: Hybrid e-4 wheelers refer to the vehicles that combine a conventional internal combustion engine (ICE) with an electric motor and battery. These vehicles use both electric and conventional power sources and hence do not come under the preview of battery operated vehicles, which inter alia includes

- i. hybrid electric vehicles,
- ii. strong hybrid electric vehicles,
- iii. plug-in hybrid electric vehicles,
- iv. series hybrid electric vehicles,
- v. series parallel hybrid electric vehicles
