#### ORDER:

In the reference 1<sup>st</sup> read above, to encourage manufacturing of electric mobility vehicles, batteries and charging equipment for EVs and increase adoption of EVs, Government has released AP Sustainable Electric Mobility Policy (SMEP) 4.0 - 2024-29, announcing competitive and best package of incentives to EV manufacturers and EV adopters.

- 2. In the reference 2<sup>nd</sup> read above, for the upliftment of MSMEs in the state, Government has released AP MSME & Entrepreneurship Development Policy 4.0 (2024-29), announcing competitive and best package of incentives to MSMEs and Entrepreneurs. In reference 3<sup>rd</sup> read above, a GO was issued giving certain additional benefits to backward community led MSMEs, to create a level playing business environment three prominent support interventions in the policy for entrepreneurs from backward communities i.e., Capital Expenditure, Power Cost, Land cost. In the said GO, at para 6, mentions to make necessary correction as made in MEDP 4.0 policy, in respective sectoral policies.
- 3. Accordingly, Director of Industries, AP, Mangalagiri has examined the changes to be made in AP SMEP Policy 4.0, in alignment with amendments made in MEDP 4.0 and submitted the revisions in AP SMEP 4.0 to the Government.
- 4. Government after careful examination hereby issue the following amendment/additions to Andhra Pradesh Sustainable Electric Mobility Policy 4.0 (2024-29) issued vide G.O.Ms.No.88, Industries and Commerce (P&I) Department, Dt: 11-12-2024. (p.t.o)

- i. Para 7.1.3.4 of Content 7.1 i.e., Power Tarifff or MSME manufacturers, pg 12, shall read as follows
  - **Power Tariff** Reimbursement of Power cost at Rs 1 per unit with annual cap of INR 15 lakh per enterprise for **5 years**.
- ii. Para 7.1.3.5 of content 7.1 i.e., Net SGST for MSME manufacturers, pg 12 shall read as follows
  - **Net SGST** Reimbursement of 100% of Net SGST paid to the state **for 5 years**, subject to the condition that incentive amount does not exceed 100% of eFCI.
- iii. Para 7.1.3.6 of content 7.1 i.e., Electricity Duty for MSME manufacturers, pg 12 shall read as follows
  - **Electricity Duty** Reimbursement of 50% of Electricity duty cost for **5 years**. This incentive is applicable only for battery manufacturers with end-use in Electric Vehicles.
- iv. Point 6 in Para 7.1.4 of content 7.1 i.e., Net SGST reimbursement for manufacturers in Sublarge and above investment categories, pg 14, shall read as follows
  - **Net SGST** Reimbursement of 100% of Net SGST paid to the state **for 5 years**, subject to the condition that incentive amount does not exceed 100% of eFCI.
- v. <u>Para 7.4.5 of content 7.4 i.e., Power Tariff for Recyclers, scrapping facilities & ATS operators, pg 17 shall read as follows</u>
  - Power Tariff Reimbursement of Power cost at Rs 2 per unit for
    5 years with annual cap of INR 15 lakh
- vi. Para 7.4.7 of content 7.4 i.e., Net SGST reimbursement for Recyclers, scrapping facilities & ATS operators, pg 17, shall read as follows
  - **Net SGST** Reimbursement of 100% of Net SGST paid to the state **for 5 years**, subject to the condition that incentive amount does not exceed 100% of eFCI.

- vii. Additional para shall be inserted after para 7.1.3.12 of content 7.1.3 which reads as para 7.1.3.13 Rebate on Land Cost
  - 75% rebate in land cost limited to INR 25 lakhs for SC/ST led Micro and Small Enterprises, setup in Industrial Estates/Industrial Parks developed by APIIC.
  - The rebate is applicable only for new units and the incentive can be availed only once on the land.
- 5. The incentives along with above mentioned amendments to SMEP 4.0 policy will be extended to eligible industries as per the operational guidelines, which shall be notified separately.
- 6. The Director of Industries, AP, Mangalagiri and the Commissioner of Transport, Transport, R&B Department shall take necessary action accordingly.
